Is Venezuela under US export controls & sanctions?

When considering Venezuela in the context of U.S. export controls and sanctions, it's essential to grasp the fundamental aspects, such as the specific sanctions in place and Venezuela's status under the International Traffic in Arms Regulation (ITAR) and the Export Administration Regulations (EAR).

What are the sanctions imposed on Venezuela?

These sanctions encompass not only sanctions on Venezuelan individuals and entities but also sectoral and financial restrictions. Under the ITAR, Venezuela is included in the 126.1 proscribed list, which prohibits the import, export, and sales from and to particular countries. This list is mainly determined by three key factors: 1.).

Are there any sanctions against insurance providers in Venezuela?

These provisions have been implemented in Norway. There are no specific sanctions against insurance providers. However, members conducting business which involves Venezuela should exercise caution, particularly if there is a US nexus, and seek legal advice. This is particularly important in the light of the volatile situation.

Can US sanctions be imposed on non-US companies in Venezuela?

Additionally, sanctions may be imposed against non-U.S. persons that are found to operate or have operated in certain sectors of the Venezuelan economy, including the petroleum sector. Non-US companies involved in the transportation of PdVSA cargo to the US must comply with US sanctions.




