# Solar inverter infringement



## Overview

---

Is there a trend in solar patent litigation?

The downward trend in the number of new solar patents has continued in the intervening years as the technology has matured, while there has been a corresponding uptick in patent litigation as solar power becomes more readily available and the commercial stakes grow higher.

What are the risks of installing a solar inverter?

The on-site health risks can further lead to other health issues and possibly death after installation. A solar Inverter installer also faces cold and heat stress and falls, leading to injuries when working with a solar Inverter panel.

Did runergy infringe on REC Solar?

REC Solar has not yet commented on the infringement allegations raised. Early in 2024, Trina Solar initiated a claim against Runergy in the US for unauthorised use of its TOPCon solar cell technology used in its Hyperion solar panels (US patents 9,722,104 and 10,230, 009).

Did Aiko solar infringe Maxeon's patent?

The Hague District Court in the Netherlands ruled that Aiko Solar did not infringe Maxeon's patent and the request for a preliminary injunction was refused. This finding has been appealed by Maxeon.


