# **Tax rate for Andorra solar container communication station flow battery services**



## Overview

---

Does Andorra pay VAT?

Although Andorra is in a customs union with the European Union, it is not part of the EU VAT area. On Janu, Andorra replaced its former sales tax regime with the Impost General Indirecte (IGI), which serves as its main value-added tax. The standard IGI rate is 4.5%, but several specific rates apply to various goods and services:.

How much tax does a company pay in Andorra?

If a company has its registered office in Andorra, is incorporated here or, effectively, is managed here then it must pay taxes on its profits. This corporate income tax is called “Impost de societats” or just IS. The Andorran corporate tax rate is 10%. For now, holding companies that invest outside of Andorra only pay a 2% tax rate on profits.

Is Andorra a tax haven?

No, technically, it is not: Andorra was officially removed from the OECD blacklist of tax havens in 2011. However and despite having all the basic taxes, the Principality has one of the lowest tax rates in Europe. Thus, the personal income tax is 0—10%, and the corporate tax on companies’ profits is 10%. The standard VAT rate is only 4.5%.

What is the VAT rate in Andorran?

6. IGI (Andorran VAT) The Principality’s indirect tax on goods and services is called IGI (short for “Impost General Indirect”). It is essentially a Value-Added Tax but is lower than in most EU countries. The general IGI rate is 4.5%, which is markedly less than the 21% in Spain or 20% in France.

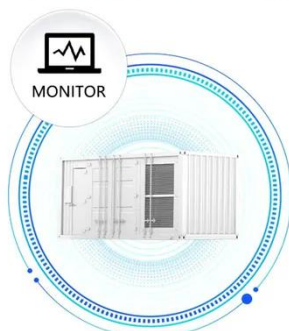
